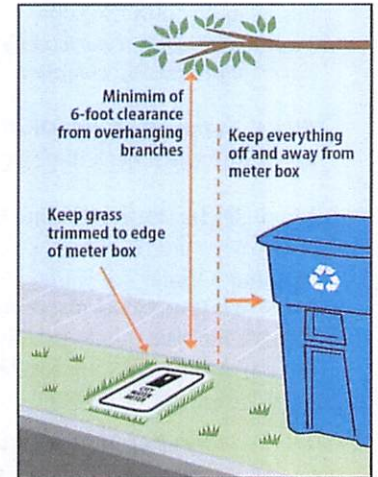

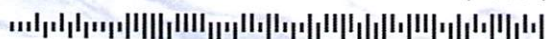

*Visa, Mastercard, American Express, Discover & E-checks are accepted. A per transaction convenience fee will be charged by the payment processing company.*

**FREE Automatic Bank Draft with use of a Checking Account** - Complete our Automatic Bank Draft Enrollment Form and return it to our office. All bank draft payments are processed on the 7th of each month.

WATER SERVICE WILL NOT BE RECONNECTED UNTIL THE ACCOUNT HAS A ZERO BALANCE.**
